COMPLIANCE TIME:

To coincide with next regularly scheduled maintenance event, but not to exceed the next fifty (50) hours time in service. (For Warranty eligibility, see the Summary section of this document.)

APPROVAL:

The alteration as specified in the instructions section of this Service Bulletin has been shown to comply with the applicable Federal Aviation Regulations and is FAA approved.

PURPOSE:

A service report has been received regarding the failure of a recently replaced Elevator Trim Wheel, P/N 43751-000. The failure of this trim wheel will not allow the pilot to manually adjust the elevator trim, but will not affect the Electric Pitch Trim Mechanism. This service bulletin mandates the replacement of the affected wheels.

INSTRUCTIONS:

1. Replacement of the P/N 43751-000 trim wheel is only applicable to those replacement wheels that have been received and/or installed since May 2, 2002. If the trim wheel has not been replaced since May 2, 2002, no further action is required. Proceed to Step 3.
2. Remove the elevator trim wheel located on the left side, near the front of the pedestal by removing the screw and washer in the center of the wheel. Retain hardware to install new wheel. Replace the trim wheel using a new replacement trim wheel per this service bulletin and the retained hardware. Ensure the wheel is seated properly.
3. Make a logbook entry indicating compliance with this Service Bulletin.
